**AN ACT**  
**ENTITLED****AN ACT** to repeal the Graded Tax Act, 1968.**ENACTED** by the King and the Parliament of the Kingdom of Eswatini.***Short title and Commencement***

1. (1) This Act may be cited as the Graded Tax (Repeal) Act, 2023.
- (2) This Act shall come into force on the date of publication in the Gazette.

***Transitional Arrangements***

2. All official documents, which, immediately before the commencement of this Act, bear a graded tax number obtained under the provisions of this repealed Act, shall continue to be recognised as valid for a period of five (5) years, after commencement of this Act, after which the graded tax number shall be replaced by the Personal Identity Number.

***Repeal of Graded Tax Act***

3. The Graded Tax Act, 1968 is hereby repealed.
